Conditions of Entry:

- 1. Entering this competition constitutes acknowledgement that PCV rules apply and acceptance of these rules
- 2. The organizing committee reserves the right to cancel any class or competition; divide any class; alter times; refuse any entry with or without stating the reason
- 3. No refunds after closing date except with vet or medical certificate. An administration fee of \$15 will be deducted. Please note that no refunds will be paid for scratchings on the day of the event irrespective of a vet or medical certificate
- 4. Barwon Valley Pony Club will refund entry fees, less incurred expenses, if the event is cancelled
- Neither the organizing committee of this competition nor the PCV accepts any responsibility whatsoever for any accident, damage, injury or illness to horses, riders, ground spectators or any other person or property
- 6. This event will comply with the PCV EI and Biosecurity Guidelines where are current at the time of the event
- 7. PCV club member cards must be inspected at the Event Office prior to riding
- 8. Open Riders
- 9. All Non-Pony Club members, and any Pony Club member who cannot show their Pony Club card or prove Pony Club membership must complete the day participant waiver and liability declaration: Non-Pony Club members and PCA/PCV members who cannot prove their PCA/PCV membership must pay \$20 per day of participation unless exempt by way of holding insurance (as per Page 2 -Liability Declaration) with an equine organization or hold their own insurance. PLEASE BRING THE COMPLETED FORM WITH YOU ON THE DAY if not completed electronically. If we need to supply a form for you, there may be a cost. The form is available here:

- 10. Gear check is compulsory for ALL riders
 - Required for all riders before competing as per the current PCA Gear Rules. The responsibility to ride in the correct competition gear remains with the competitor. If any judge or official discovers a competitor riding with incorrect competition gear, elimination may occur.
 - Pure Dressage, Horse Trials, Combined Training & Short Course Dressage: A whip not exceeding 1200mm including the lash is permitted for Grades Adv, 1, 2 & 3. EA Tests Preliminary and above. A whip not exceeding

750mm including the flap is permitted for Grades 4, 5 & 6, EA Preparatory tests.

- 11. Medical armbands are optional
- 12. Helmets: Correct 'standards' numbered helmet must be worn as specified in PCV Gear Rules. Spot checks may occur during the event, and an incorrect helmet will mean elimination
- 13. Competitor numbers will be pre-allocated and rider numbers will be advised with rider times & draw
- 14. Bridle & saddle blanket numbers are to be supplied by all competitors. All competitors must also provide their own Cross-Country bibs and print their rider number supplied with the event times. Body numbers MUST be worn during the Cross-Country phase of the event. In Dressage & Show Jumping, bridle/saddle blanket numbers may be used
- 15. Riders under the age of eight years may not compete in Horse Trials
- 16. Horses must be at least four years of age; no stallions, colts or rigs are permitted
- 17. More than one horse may be ridden subject to the conditions of PCV Handbook of By-laws multiple horse rules

- 18. Queries, protests, horse abuse rules as per the PCV Handbook of By-Laws
- 19. Dogs & pets, smoking and alcohol are prohibited without exception within the Mount Moriac Equestrian Facility during this event. Failure to comply will result in competitor elimination. PCV Alcohol policy applies
- 20. Lungeing is not permitted at this event as there are no enclosed areas available
- 21. Day yards must comply with PCAV requirements. The use of electrified tape, strings, ropes, or chains is not permitted at Pony Club Events. Electric tape can be used as a top line or as a "standoff" on a steel or solid yard, but not as a standalone yard
- 22. Horse trials Cross-Country & Show Jumping maximum heights and maximum spread distance as per PCV HT Rules 2022
- 23. HELPERS ALL riders, are required to provide one volunteer to be nominated to assist on the day, through the sign up app that will be notified upon entry
- 24. Media & Digital Publication PCV or Open riders and families that are involved or attending our Horse Trials event may be photographed by official photographers, local media or event organizing committee; these digital images may be used to promote the event, and future events, in newsletters, flyers, websites and other promotional activities for the Barwon Valley Pony Club & PCV
